RESOLUTION

No. 104-Emp.—5th August, 2009.—The Governor is pleased hereby to make with immediate effect, the following amendments in the Udiyaman Swanirbhar Karmasansthan Prakalpa (USKP), 2008, introduced under this Department Resolution No. 01-Emp., dated 15.01.2009 :—

Amendments

1. Under the heading "Definition" after item (3) *insert* the following item :—

(d) "Partially employed person" includes and means seasonal workers, part-time job workers on daily wage basis or those working on commission basis, i.e. engaged purely on extra-temporary work.

2. Under the heading "Eligibility"—

(A) In item (iii) *substitute* the words "not defaulted in repayment of" by the words "fully paid".

(B) In the first *proviso substitute* the words "30th September" by the words "31st December".

(C) In the second *proviso*—

(a) Omit the following words—

(i) "Handicapped or"

(ii) "Under SESRU"

(b) After the words "for this purpose" *insert* the following words — "or candidates belonging to the Scheduled Caste, Scheduled Tribe, Other Backward Classes, Ex-Serviceman, Minority Category and also female registrants".

3. Under the heading "Coverage" *substitute* the words "All the participating banks under the SESRU Scheme" by the words "All the nationalised banks, Government financial institutions and other banks as may be prescribed by the State Government".

4. Under the heading "Maximum Project Cost" after item (iv) *substitute* the entire *proviso* starting with the words "However, there shall not be any objection" with the following words :—

"Notwithstanding anything contained in Para 7 of this Scheme, there shall not be any objection if any sanctioning bank, having examined the viability of a proposal submitted by a person and approved by the District Level Expert Committee, sanctions a higher amount of loan though the subsidy amount to be released by Labour Department shall be limited to Rs. 12,500/- only".

5. Under the heading "Screening" :—
- (i) In Item (iv), *substitute* the words "one of them" with the words "the Employment Officer-in-Charge of Sadar Sub-Division".
 - (ii) In the last para after the words "The Chairman of the Screening Committee will thereafter send" *substitute* the words "bankable proposals to different bank branches" with the following words —
"the recommended proposals to the Officer-in-Charge of the Employment Exchanges concerned and in turn he shall sponsor these cases to different bank branches".
6. The resolution under the heading "Repayment" shall be *substituted* as follows—
- "(1) The repayment period would be five to seven years. The initial moratorium period shall be prescribed by the banks concerned".
 - "(2) Any demand for recovery of loan or default in repayment under the Scheme shall be treated as a public demand under the Public Demand Recovery Act, 1913".
7. Under the heading "Reporting System" in item (b) after the words "taken on recommended cases" *delete* the word "received".
8. In Annexure-I, after item (12) insert the following item—
- "13. Whether received any Self-Employment loan under the Government, and if yes whether the loan has been fully repaid".
9. In Annexure II
- (A) After item 4, *insert* the following item—
 - "5. I have fully repaid the loan (give the name of the Loan / Scheme) taken on
from (bank /Financial Institute) and the last date of repayment of the instalment of the said loan
was..... (date) and renumber the item (5) and item (6) and item (7) respectively".
 - (B) Renumber the existing item Nos. (5) and (6) as (6) and (7) respectively.
10. *Substitute* the expression "District Level Expert Committee", wherever the same exists in the scheme, by the expression "Screening Committee".
