NOTIFICATION

In exercise of the powers conferred by sub-section (a) of Section 3 of the West Bengal Regulation of Recruitment in the State Government Establishments and Establishments of Public Undertakings, Statutory Bodies, Government Companies and Local Authorities Act., 1999 (West Bengal Act XIV of 1999) ex- census employees who had worked in 1981 Census Operations and/ or in 1991 Census Operations were declared as 'Exempted Category' vide Notification No.301-EMP/ 1M-10/2000 dated 21/08/2002 issued from the Labour Department, Government of West Bengal.

2.0 Earlier, the Director of Census Operations, West Bengal vide memo. no. CEN/11007/Misc./2009/1009 dated 12/13.06.2012 informed the Additional Secretary to the Government of West Bengal, Labour Department that during Census 2001 the general guidelines for appointment of Enumerators and Supervisors was that the "Enumerators are to be drawn from School teachers, Government Officials, Officials from Local or Statutory Bodies, Public Undertakings, Semi Government Offices, qualified social welfare or Health Workers etc. But no job workers, ex-census workers or those not on the pay roll of the above bodies are to be engaged for Census enumerations." Similarly, the "Supervisors are to be drawn from School Head Masters, Senior Teachers, Land Revenue Officials, Sub-Inspectors of Government Departments, U.D.C.s in Government offices or officials of similar rank" (Reference: — Guideline for House-listing Operations and Household Enumeration-Census 2001 issued by the Directorate of Census Operations, West Bengal). The same principle was maintained with regard to engagement of Enumerators/ Supervisors during 2011 Census Operations as informed vide letter no. CEN-11007/Misc./2013/2086 dated 22/12/2015 of the Directorate of Census Operations West Bengal and it was further emphasized therein that no unemployed person has been engaged in Census works during 2011 Census Operations.

- 3.0 Now therefore, after careful consideration of all the matters and in partial modification of this Department's Notification No.301-EMP/1M-I0/2000 dated 21/08/2002 and in modification of the earlier MEMORANDUM No.60- Emp./1L-23/13 dated 25/03/2015 read with MEMORANDUM No.355- Emp./Emp.IL-39/2015 dated 31/12/2015, the Governor is pleased to decide that a person claiming to have worked in 2001 and/or 2011 and/or in subsequent years' Census Operations cannot be included in the "Exempted Category" for the purpose of the above Act,1999 (West Bengal Act XIV of 1999).
- 4.0 The Governor is further pleased to decide that persons who had worked in the year 1981 and/or 1991 Census Operations but had not submitted applications within the cut-off date i.e. 30/06/2001, as stated in MEMORANDUM No.75-Emp., dated 06/02/2001 for inclusion of their names in the Exempted Category for the purpose of above Act, 1999 (West Bengal Act. XIV of 1999), will not be considered for inclusion in the Exempted Category.
