

Such re-employment will be fixed for a period not exceeding 01(one) year from the date of joining and may be renewed on year-wise basis on being satisfied with the service of the Officer concerned. In no case, however, re-employed officer will be allowed to continue with service on attainment of 65 (sixty-five) years age.

3. The Officer to be selected for such re-employment will get remuneration along with all other financial benefits as per Government Norms. If required, Finance Department may be consulted for this purpose.

4. The applicants should not be above 64 (sixty-four) years of age as on 01.03.2024.

5. The applications in the format as attached herewith are required to be duly supported with the following particulars and should reach this Department positively within 01 (one) month / 30 (thirty) days from the date of publication of this Notice on the departmental website:


