Legislative Assembly from 7- Dinhata, 86 - Santipur, 109 - Khardaha and 127- Gosaba (SC) Assembly Constituencies, 2021 to be held on 30th October, 2021 (Saturday) vide Press Note No. ECI/PN/83/2021 dated 28.09.2021 of the Election Commission of India.

The filling stations are granted exemptions from the operations of provision of Sub-Section (2) of Section 6 of the said Act, subject to the condition that any work done beyond eight and half hours a day or forty eight hours a week shall be regarded as overtime work for payment of overtime wages under section 13 of the said Act.
