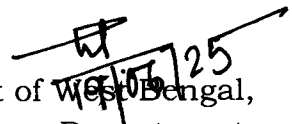

If there be any error then power of lens/glass should be mentioned. A candidate even with slightest error must wear correction glass/lens to show it before the Medical Board.
2. A **pathological report of Urine (R/E)** from any **competent pathologist**, wherein the specific gravity, albumin, sugar, cast and cells of urine should be categorically mentioned.
3. **X-ray Report of Chest** with plate from a competent **radiologist**.
4. **Two (2)** recent passport size photographs.
5. One address proof with photo I.D [**Aadhar card** or **Voter card**] – both original and self attested photocopy.
6. Admit card of the examination/Selection letter - both original and self attested photocopy.
7. Original P.H. certificate along with one self attested photo copy of that certificate if the candidate is physically challenged.

It will appear from the list that **1 (one) S.C. candidate, Shri SUBHAJIT MANDAL (bearing roll no. 6000734)** has ranked amongst the first 102 (one hundred two) candidates by virtue of his performance at the interview and as such he is being recommended against 1 (one) **Unreserved vacancy** in terms of Notification No. 3662-L dated the 3rd October, 1980/G.O. No. 30(70)-TW/EC dt. 22.01.1997.

No other candidate was available for appointment to the remaining 58 (fifty eight) posts including 20 (twenty) reserved for E.W.S., 12 (twelve) for S.T., 12 (twelve) for O.B.C.- B (NCL), 10 (ten) for P.D. (UR) and 4 (four) for P.D. (SC). In fact no P.D. (UR) candidate and P.D. (SC) candidate appeared in the Screening Test. Out of 10 (ten) E.W.S., 8 (eight) S.T. and 26 (twenty six) O.B.C. – B candidates, who appeared in the Screening Test, 7 (seven) E.W.S., 7 (seven) S.T. and 19 (nineteen) O.B.C. –B candidates appeared at the interview.

The Appointing Authority is requested to verify the following particulars in respect of the recommended candidate(s) before they are offered appointment:–

- (i) the statements of the candidates made in the application regarding date of birth, educational qualifications, caste etc. with reference to the valid original certificates,
- (ii) the caste certificates as per provisions of the West Bengal Scheduled Caste & Scheduled Tribes(Identification) Act, 1994 and West Bengal Commission for Backward Classes Act, 1993 & subsequent notification no. 6320-BCW/MR-84/10 dated 24th September, 2010,
- (iii) the photograph and signature of the recommended candidates in the applications.

The Appointing Authority, before appointing a person seeking appointment on the basis of reservation to O.B.C.s should verify the veracity of the Community certificate submitted by the candidate and also the fact that he/she does not fall in the 'creamy layer'.

The Appointing Authority is also requested that in case of appointments against vacancies reserved for O.B.C.s, the following clause in the offer of appointment should be inserted: **“The appointment is provisional and is subject to the community certificate being verified through the proper channels. If the verification reveals that the claim of the candidate to belong to O.B.C.s or not to belong to creamy layer is false, his/her services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of extant laws in force for production of false certificates”.**

The Appointing Authority is requested that in case of appointments against vacancies reserved for E.W.S.s, the following clause in the offer of appointment should be inserted: **“The appointment is provisional and is subject to the Income and Asset Certificate being verified through the proper channels and if the verification reveals that the claim to belong to EWS is fake / false the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of fake / false certificate”.**

The recommended candidates have not been medically examined nor have their antecedents been verified by the Commission.

I am to request that the integrity of the candidates, who are the employees of Govt. of West Bengal, may be verified by the Appointing Authority before they are offered appointments. In case the report in respect of any of them is unsatisfactory and the candidate is considered unsuitable for appointment on grounds of integrity the matter may be referred back to the Commission along with the report for further action.

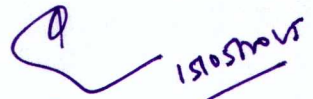

I may add that the Commission has also drawn up a **Reserve List** which includes 204 candidates [89 (eighty nine) General, 72 (seventy two) SC and 43 (forty three) OBC –A category] for filling up the vacancy occurring only due to non-joining of the recommended candidate within the period of validity upto the **30th April, 2026**.
