

MEMORANDUM

In connection with the General Elections to 4(Four) Municipal Corporations i.e. Siliguri Municipal Corporation, Chandernagore Municipal Corporation, Bidhannagar Municipal Corporation and Asansol Municipal Corporation scheduled to be held on **12th February, 2022 (Saturday)** vide W.B. State Election Commission Notification No. 241-SEC/1E-99/2021 dated 15.01.2022 in compliance with the Notification No. 284(2)-SEC/1M-30/2021 dated 19.01.2022, issued by the State Govt., the undersigned is directed to declare that, it has been made obligatory on the part of the employers of any business, trade, industrial undertaking or any other establishments in all areas pertaining to Siliguri Municipal Corporation, Chandernagore Municipal Corporation, Bidhannagar Municipal Corporation and Asansol Municipal Corporation to grant paid holiday on the day of Poll to their workmen who are voters in the said constituency areas, so as to enable them to exercise their right of franchise.

I am, therefore, directed to issue instruction to all shops, commercial and industrial establishments, pertaining to Siliguri Municipal Corporation, Chandernagore Municipal Corporation, Bidhannagar Municipal Corporation and Asansol Municipal Corporation area, in whose units Saturday, the 12th February, 2022 is a working day, to grant a paid holiday on 12.02.2022 (Saturday) to all categories of workers and employees who are voters in the said constituency area to enable them to exercise their right of franchise in the election.
