Whereas in exercise of the power conferred by clause (a) of sub-section (I) of section 5 read with section 9 of the Minimum Wages Act 1948 (Act XI of 1948) the Minimum Wages Advisory Committee on Tea for the State of West Bengal was constituted vide this department notification no. 20-MW/2W-16/2010 dated 17.02.2015 to hold enquiries and advise the State Government in the matter of fixing and revising the minimum rates of wages payable to the employees employed in plantation of tea in the State of West Bengal. The Committee was enlarged vide this department notification no. 28-MW/2W-16/2010 dated 04.03.2015 to accommodate some persons acquainted with the matters.

Now in view of the expiry of the two-year term of the Committee as well as death, retirement or unavailability of some of its members and since the matter of fixation of minimum wages for tea garden workers is at its advanced stage, the Governor is pleased to reconstitute the Committee for the same purpose with the following members:
