ORDER

A Committee is hereby formed for engagement of Private Hospitals / Nursing Homes /Diagnostic Units to impart Secondary Medical Care Services under Specialty covering both Indoor Treatment and Medical Diagnostic Procedures under tie-up procedure at par with Non-NABH and Non-NABL CGHS Rate for Kolkata as detailed below:

2.	Director, ESI (MB) Scheme, West Bengal	Member Convenor
3.	Labour Commissioner	Member
4.	Deputy Director (Planning), ESI(MB) Scheme, West Bengal	Member

The Committee will also look into the different grievances regarding the matter of exclusion from existing list of tie-up Hospitals / Nursing Homes / Diagnostic Units and redress the same.

The Private Hospitals / Nursing Homes must be situated in the areas where ESI has already been implemented or in the areas which are proposed to be brought under coverage of ESI as per latest Non-NABH (for indoor treatment) and Non-NABL (for medical diagnostic procedures) CGHS Rate for Kolkata, if applicable for those areas.

The Director, ESI (MB) Scheme, West Bengal will execute the agreement after obtaining necessary approval / recommendation of the committee.

The expenses incurred against such engagement will be met from Corpus Revolving Fund following usual procedures which has the approval of Finance Department vide their U.O. no. 119 Gr. 'L' dated 05.07.2012.
