Clarification on Property tax and other Incentives for IT/ITeS Companies in West Bengal

The West Bengal Information Technology and Electronics (IT&E) Policy, 2018, which became effective from 13th August 2018, remains in force until further orders as per the IT&E Department's notification no. 653-ACS/IT/O/95/2017-Pt-I dated 13.08.2018.

The ongoing incentives under the IT & F. Policy 2018 are enumerated below.

- (i) The incentive policy of Commerce and Industries and MSME Departments will be followed mutatis notandis.
- (ii) Extra 15% Floor Area Ratio (FAR) will be allowed for IT/ITeS Buildings.
- (iii) Exemption of property tax of 50% will be given for 12 years, i.e. uptil 12th August 2030
